4. The Summer Vacation of the Court will commence on Monday the 10th May, 2004 and the Court will resume its sitting on Monday the 5th July, 2004. The Summer Vacation is shaded in red. The Registry of the Court will, however, be functioning throughout the vacation except on Saturdays, Sundays and Holidays. However, the Registry of the Court will remain open on last Saturday of the Summer Vacation i.e., 3rd July 2004.
5. Idu'z-Zoha, Muharram, Milad-un-Nabi and Idu'l-Fitr, which fall on 2nd February, 2nd March, 2nd May and 15th November respectively are subject to change depending upon the visibility of the Moon. If the Government of India declare any change in these dates through TV/AIR/News paper, the same will be followed.
6. During the Christmas Holidays, the Registry will remain closed from 25th December, 2004 to 1st January, 2005. (Both days inclusive).
